Allotment	It allows allotment of funds i.e. both financial and physical at various hierarchy of offices within the department.
Utilization	It allows to process monthly utilization details.
Resumption	It provides functionality to re-capture the balance amount to the corresponding head of account at any office to which fund is allotted by the reporting office.
Reappropriation	It allows transferring unutilized amount from any HOA to another HOA that requires funds.
Surrender	It allows any office that has a sum of money allotted during a financial year that has not been utilized to be surrendered back to the office that has been allotted the same.
Contingent Bill	It allows generating contingent bill for particular purpose for all departments.
Expenditure monitoring	It allows reviewing the entire contingent bills of each department by authorized users.
Treasury Reconciliation	It provides functionalities to reconcile the bills against treasury book of accounts to generate reconciled statement of both financial and physical at various offices and verified by the reporting office.
System Admin	Provision to create user as per authorities and also can set their functional privileges.
